THSLL/TSLA MEETING MINUTES

Date: September 30,2025

The THSLL Board Meeting was called to order by Troy at 7:08pm.

In Attendance: Elizabeth Dupont, GL Van Dyne, Sean Ray, Tony Martin, Troy Walker, Non-Voting: Nancy Powers, Chris Shaffer Not attending: Andris Dikmanis-proxy to GL, Will Doby-proxy to Troy, Monica Joy

1. Voting Structure and Percentages

- Discussion: Nancy presented the draft Voting Form for non-attending members, noting the inclusion of the required 51% (League Play) and 67% (League Structure) voting thresholds as per the rule book.
- Action/Decision: The board confirmed the current classification of voting items and the required percentages are correct.
- Clarification on Required Majority: The 67% requirement for League Structure votes must include votes in attendance, by proxy (delegate), or by voting form.

2. League Play Voting Items (51% Majority)

- Item 1: Budget: Remains under League Play (51% majority). Nancy will present.
- Item 2: Timetable: Nancy will present.

3. League Structure Voting Items (67% Majority)

- Item 3: 60/80 Shot Clock Reset (NCAA Rule Implementation)
 - Discussion: Discussion focused on the clarity of the ballot wording. The current THSLL rule is an 80-second reset after a shot-on-goal; the NCAA rule is an 80-second reset across the midline and a 60-second reset after a shot-on-goal.
 - Clarification: It was agreed that the vote is to Implement the NCAA 60/80 Shot Clock Rule (reset to 60 seconds after a shot on goal). Sean will present. The rule change, if passed, would be League-wide and not divided by class to maintain consistency.
- Item 4: Dual Division Teams Required to Field a JV Team
 - Background: Dual Division teams were required to field JV teams in the past, but with the requirement was not included in the class realignment. Will Doby will present.
- Item 5: Restructuring Class D
 - The proposal is to eliminate Class D playoffs and awards. Rationale: Class D has not fostered the intended development, and the Championship may encourage C teams to drop down to D. Alternative Options for Class D Teams: Join Class C or Class JV and play full-season lacrosse, Compete in the Sixes division.
- Item 6: Sixes Discussion: Minimum of 6 games played, Secondary team name majority of players outside of Host school
- Item 7: Independent Class District-Teams opt in before season begins, All Independent teams must play each other, Top 6 qualify for AA playoffs, Remaining Independent teams qualify for A playoffs which

remain in a 16-team bracket, equal number of home and away games, Class A teams must play 2 games vs Independent teams
