## AGENDA TOPICS

Mike Ormsby introduced Board Members.

Kellie Schindel called roll. There were 72/89 programs present on the call or by proxy, which is equivalent to 81% of the league membership.

**Agenda topic** 2022-2023 Timetable | **Presenter** Nancy Powers

Teams were given the opportunity to choose between Timetable A and Timetable B. Timetable B was edited to reflect that Mother's Day weekend is later in 2023, giving teams more time to complete the regular season.

19 teams voted for Timetable A

47 programs voted for Timetable B

**Agenda topic** Appendix A Waivers | **Presenter** Nancy Powers

The following waivers to NCAA Rules (Appendix A of the THSLL Rulebook) were presented and program were given an opportunity to comment and ask questions.

Mike asked for any dissenting voted. Seeing none, the waivers were approve unanimously.

---

*Agenda topic Participation Percentage Waiver | Presenter Joe Donoghue*

Joe presented data on the number of teams that would be ineligible for the playoffs with the current League Restructure Rule in place. Teams were given an opportunity to comment and ask questions.

Joe moved to approve the following:

1. Teams that fall below the required Team Participation % have a choice between one of the two options:

a) The THSLL program can remain in their current class and Team Participation%, participate in District Games within their Class and District, but will be ineligible for State Playoffs.

or

b) The THSLL program can move up to the next THSLL Class and remain eligible for State Playoffs for the 2023 and 2024 seasons.

The deadline for teams to make this choice is November 1, 2022.

2. In consideration for playing in Class A (highest competition), teams that are not compliant with the Team Participation% will be waived for the 2023 and 2024 seasons.

3. New teams that are within the first five years of participating in the THSLL can remain in their existing Class and are eligible for THSLL State playoff events.

4. If approved, this waiver will expire at the end of the 2024 season. The THSLL Coaches can vote again to either renew the waiver, allow it to expire or implement something else.

5. The THSLL Board reserves the right to revoke this waiver to any team that benefits from this waver and creates a competitive disadvantage to teams within their competitive Class.

6. The waiver will only consider roster percentages and not individual player caps.

Motion carried with 80% of the membership programs voting yes.

Tony Martin and Mike Ormsby presented information on potential 7v7 division for 2024 season.
