Agenda topic Participation Percentages | Presenter Joe Donoghue

Discussion

The Coaches' Committee met to discuss the participation percentage requirements for the 2023 season. 100% of the committee members were in attendance. One coach was in favor of doing away with the participation percentage requirement. The remaining coaches are in favor of keeping the requirement. Several rule change proposals came out of the meeting. These rule change proposals will need to be voted on at the Annual State Meeting.

Joe moved to proceed with advancing the following rule change for a vote by the membership (final language TBD).

- 1. Per league rules, teams that do not meet their roster percentage are not eligible for state playoffs. Considering the high percentage of teams not meeting this requirement (~25%) and the difficulty that many of these teams would have meeting this threshold anytime soon, teams under the that do not meet the requirement should have the option of doing one of the following:
 - A. The team can remain in the current Class where they are currently assigned but would be ineligible for state playoffs.
 - B. The team can move up and participate to the next highest class and remain eligible for the state playoffs for a period for two seasons. At the end of two season period, the THSLL Board will review that status of the team with regards to competitiveness within the Class, roster numbers, progress toward meeting the roster percentage requirements and other factors. If at the end of the two-

year period the roster percentage is not met, the THSLL Board can decide to either extend the two-year period at the higher class, move the team into yet another higher class if available, or rule that the team be ineligible for state playoffs per option A.

Under this option, the Board should consider granting a two-year waiver to teams that are at 70% or greater under the condition that that the percentage requirement is met after two seasons.

2. The League should create a waiver for teams that are in underserved areas that are unlikely to meet the roster percentage requirements including conditions for this waiver to be granted. (Example Bridge Lacrosse).

3. in addition to State Champions automatically being moved up to the next highest class, the runner up should also be moved up with the exception of Class D teams.
