Agenda topic Georgetown/Gateway | Presenter Jim Raney

### Discussion

Players are citing releases from Coach Breger as justification for them to move to Georgetown program. Board agreed that a coach's release of player(s) does not automatically make players eligible to play for another program. The THSLL Board has the final determination as stated in Rule 8.7.5.

The eligibility of 8 players was discussed.

Board agreed that the 5 players who attend Gateway, will play at Gateway.

An additional player, who is currently injured, would also need to play at Gateway if he returns to play. Coordinator will monitor this.

Another former Gateway player has transferred to East View HS which is part of the Georgetown ISD and feeds Georgetown Lacrosse. This player will be eligible to play for Georgetown upon receipt by the Board of his proof of enrollment and residency and after waiting the 2 week transfer time as delineated in Rules 8.6, 8.7 and 8.7.2 of the Rulebook.

The last player played at Gateway last year as a freshman. He attends Hendrickson HS. His primary residence is in Pflugerville. He is seeking a Hardship Waiver for the following reasons:

*Student attends Hendrickson High School. The last bell at Hendrickson is at 4:15pm; by the time the player leaves school is 4:25pm. Player arrives at dad's home at 4:40pm. By the time the player reaches Gateway it would be 5:00ish. Gateway starts lacrosse practice at 2:05pm and they have an athletic period dedicated to lacrosse. The player would not be able to attend any of the practices at Gateway. This would stunt the players growth and his development as a lacrosse player. Player is seeking a hardship waiver to Georgetown which is the closest DII School that accepts outside players. Georgetown's practices are from 6:15pm - 8:15pm.*

No determination was made on this call.

An additional player was discussed, who is not seeking to move programs. His eligibility to play at Gateway was questioned. Board agreed that player is playing with the correct program per the 8.0 Rule.

*Has an issue with a lack of structure and commitment of the Rouse program, no players at their practices and issues with how their coach runs practices. Has played with the feeder program, the Cannons, for several years with many friends on the Vista Ridge team.*

This waiver was denied.

The second waiver is for a player who attends McNeil HS in RRISD. The reason given is as follows:

*Their residence is 11.1 miles from Westwood High school, which is where he would be playing due to the merge of the McNeil program, 11.1 miles from Cedar Ridge, 12.4 miles from Georgetown, 7.0 miles from Rouse, and 5.5 miles from Vista Ridge. Due to their distance from Westwood, it would be difficult for them to make it to the Westwood practices with the other McNeil players and Vista Ridge is the closest program to their home. He has also played with many of the players on Vista Ridge because he played with the CPL Cannons, the youth team for Vista, so he's tied in with the players on the team already as well.*

More information was requested by the Board on this waiver. The Board will vote by email to expedite the process.
